1. Payment Process

WOLF has created an automated process that allows crypto to be automatically accepted by all our suppliers without the use of gift cards or any other money laundering schemes.



2. Separation of WOLF and Global

Wolf coin has created a separate site for all US residents that complies with the regulations imposed by the US. With the ever-growing adoption of crypto, WOLF wants to make sure that all its customers are shopping with ease without the fear of being associated with illegal activity. Wolf coin has collaborated with richmart to help track any illegal and/or suspicious activity that will help wolf coin adhere to Anti-Money Laundering regulations.



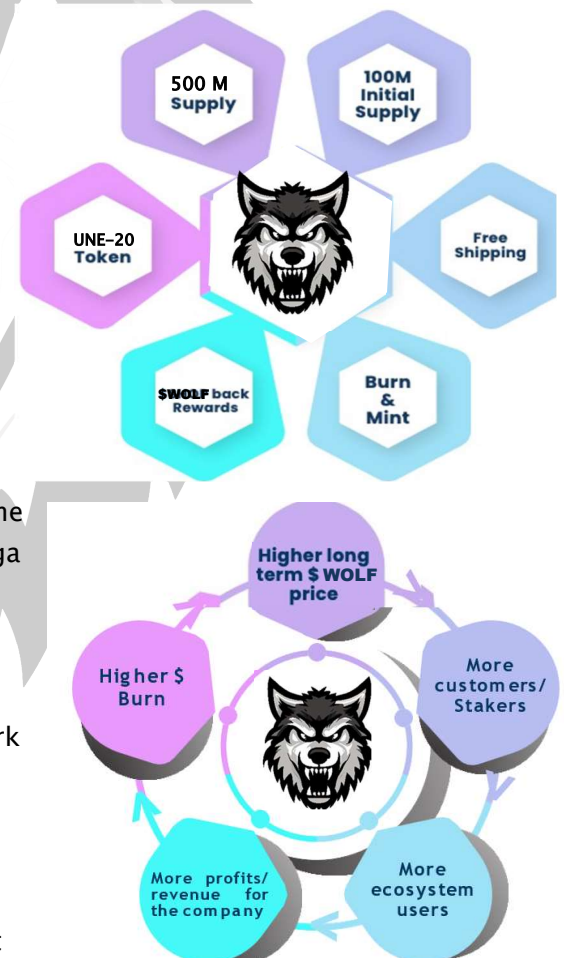
WHAT IS \$WOLF

\$WOLF native COIN, \$WOLF (UNE-20) , is built on the Uni blockchain and serves only a utility COIN within the most of the online shopping Portal, websites and systems as well as Mega marts and centralized outlet. \$WOLF provides numerous benefits which greatly encourage users to utilize the WOLF ecosystem. Read on to learn more about the use of \$WOLF as well as its benefits and COINomics.

COINOMICS OVERVIEW

The \$WOLF COIN will serve as a reflection of the success that awithing the most of the online shopping Portal, websites and systems as well as Mega marts and centralized outlet will bring forth as a company, The structure of the \$Wolf COIN will consist of the following elements:

- The COIN will initially be hosted and launched on the UNE network Makin it a UNE-20 COIN
- Upon launch \$WOLF will have a COIN Circulation Supply of 100 million with initial supply and Total Supply of 500 million.
- There will be a COIN burning and a COIN mining mechanism that will drive the economy of COIN



COIN SUPPLY

With the new smart contract we will now be able to correlate the success of our ecosystem with that of our new \$ WOLF COIN through revenue burning. Therefore, there will be no max cap as we are truly confident in the revenue that online shopping Portal, websites and systems as well as Mega marts and centralized outlet is capable of producing as an ecosystem.

This is also extremely beneficial because if a max cap were in place, burning of the COIN supply would come from its total supply and not its circulating supply. The circulating supply will have an initial launch of 100 million COINs with total supply of 500 million COINs and will then be calculated solely around the difference of minted and burned COINs. As WOLF continues to succeed in producing revenue, \$WOLF COIN will transition into a deflationary COIN as it will burn more COINs than it mints.



BURN AND MINE MECHANISM

Our vision is for \$WOLF to be a mintable COIN that is obtainable through a newly implemented \$WOLF back system that will work hand in hand with transactions/purchases users make through the online shopping Portal, websites and systems as well as Mega marts and centralized outlet's ecosystem. This will ensure that customers not only become holders, but are also incentivized to use online shopping Portal, websites and systems as well as Mega marts and centralized outlet's platform. Therefore the minting mechanism will be instrumental in increasing the amount of holders and also critical in uniting holders and customers.

In contrast, we will be creating a COIN burning mechanism where a portion of online shopping Portal, websites and systems as well as Mega marts and centralized outlet's ecosystem (which also includes present and future online shopping Portal, websites and systems as well as Mega marts and centralized outlet products like Shopping Pay, Metaverse, etc.) revenue will be used to buy and burn \$WOLF periodically. This will ultimately align the success of online shopping Portal, websites and systems as well as Mega marts and centralized outlet with its COIN, which was previously not the case.

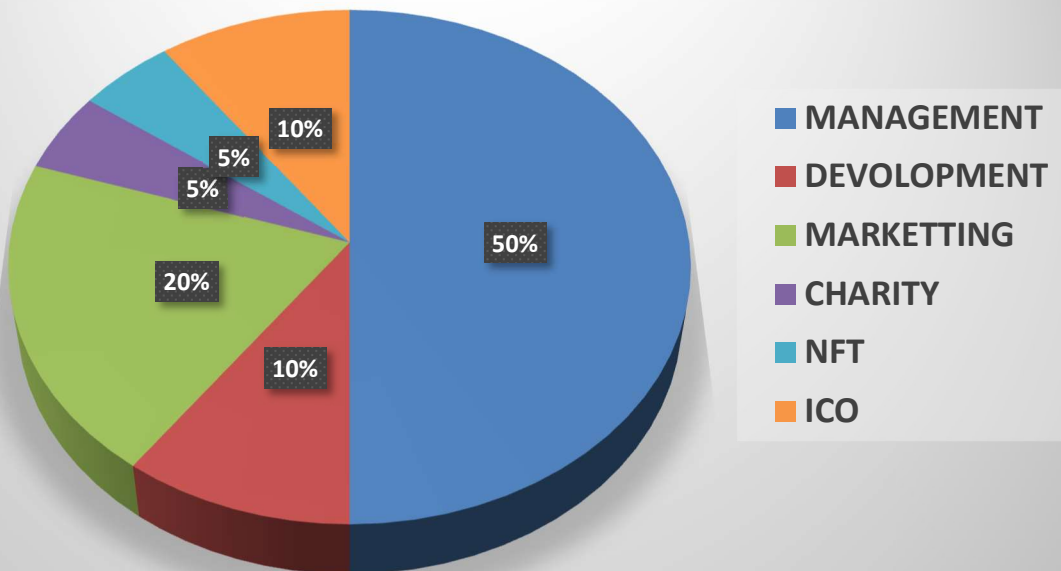

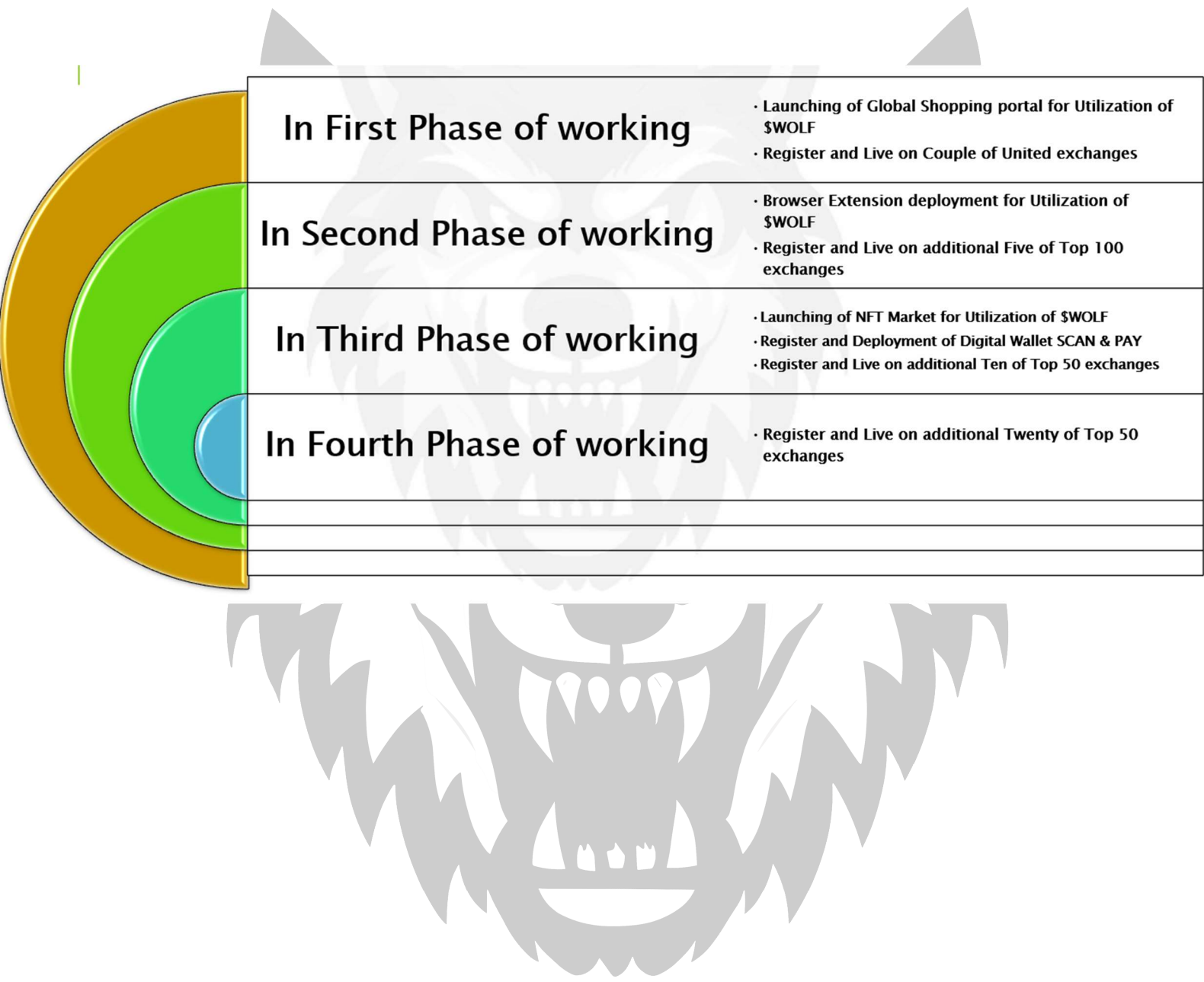
